Lextran completes purchase of former General Electric site

The Lextran Board of Directors voted in June to enter into an agreement with General Electric for the purchase of the 13.69 acre tract of property at 200 West Loudon Avenue, former site of the GE Lighting Kentucky Glass Plant. The purchase, which was contingent upon approval from the Federal Transit Administration (FTA) and the completion of the 90-day due diligence period, is now complete and Lextran has assumed ownership of the property.

Lextran will use this property to construct a new facility just steps away from their current location at 109 West Loudon Avenue. The move to the GE site will allow Lextran to develop a cost-effective and efficient operations and maintenance facility that will meet the future needs of Lexington. In addition, the move will consolidate administrative functions which are currently housed at two locations.

Rocky Burke, Lextran's General Manager, welcomed the completion of the purchase, stating, "We are so excited to have taken another step forward in this process. This move is critical for Lextran's continued advancement and our ability to provide first-class bus service to the people of Lexington."

Lextran's purchase of the GE site utilizes a vacant industrial site in Lexington. Consistent with trends around the country, GE's clean-up and Lextran's redevelopment plans for the site have been studied and approved by the KY

Department of Environmental Protection as eligible for the Kentucky Brownfield Redevelopment Program, which promotes the re-use of former industrial sites.

The GE Lighting Kentucky Glass Plant opened in 1946 and manufactured several different types of glass for light bulbs prior to its closing in July 2010. Since the plant ceased operation, the property has been vacant.

STATEWIDE KENTUCKY OVERALL TRANSIT SYSTEM AWARD

Transit Authority of Northern Kentucky (TANK). provides transit service in 35 cities within their service area that encompasses over 265 square miles.

They provide close to 4 million trips and travel over 4.6 million miles annually. This transit system utilizes all the latest advanced technology to provide services which help improve traffic flow, protect the environment and assist in the economic development of their transportation region.

They have their own mobile App that provides riders with on-demand, location aware bus routes, times, and trip planning tools.

Google Transit is available on their website, which allows people to have access to detailed trip planning from home to work.

Their buses are equipped with bike racks for easy on-easy off bike loading, which offer riders another way to get around while getting some exercise and saving on high gas prices.

In 2013 their employees and board members started a special fund to help make life easier for their loyal riders with special needs. Board members gave personal gifts to launch the fund and shortly after the employees also began contributing to the fund by payroll deductions. This fund provides financial assistance to their users who find it difficult to pay even the small fare for their transportation. Their employees are true role models. They could have looked the other way, but instead they decided to help their fellow citizens who they see every day. They are truly an inspiration for all of us!

Not only does this system operate efficiently and show their compassion for their customers, but they also managed to do all of this while being in compliance with FTA rules and regulations. They received ZERO deficiencies during their last FTA review. Which we all know is not an easy thing to do.

OUTSTANDING STATEWIDE SECTION 5307 URBANIZED PUBLIC TRANSPORTATION SYSTEM

Lextran transit system operates a fleet of 73 vehicles which includes vans and 35 to 40 foot buses. They provide over 6 million trips a year.

This transit system offers many services to benefit its community, including a shuttle service for the local university, door to door Paratransit service and a JOBS Bus service to help individuals get to and from work during late night hours.

The COLT Trolley is a free circulator service connecting two universities and the downtown.

LexTran also thinks of their customers first and makes public transit as convenient and customer friendly as possible.

Buses are now being provided with onboard digital advertising. This advertising will broadcast onboard advertisements at specific times and locations on the routes and can also broadcast public service information. The digital audio announcements will play in tandem with text scrolls on the bus marquees.

One of the most exciting ventures undertaken by this system has been their partnership with Art in Motion as part of a \$150,000 state and federal transportation grant for the design and construction of up to 8 art shelters. The design of the shelters is put out for competition through public contests for the design of each unique art shelter. Each shelter and area will have a theme on which to base the design. Thus far, there is a shelter made of bottles, another is a tribute to a renovated historic theater, another revolves around horses and another is a garden theme. Lex Tran has other partners and participates in many other programs such as Safe Place and Transit Watch to help ensure the safety and security of the riders and of the general public. Because of their innovations and commitment to public services.

OUTSTANDING STATEWIDE SECTION 5311 PUBLIC TRANSIT SYSTEM

Rural Transit Enterprises Coordinated, Inc. (RTEC) is really a Giant when it comes to rural public transportation in the Commonwealth. This system operates in more rural counties than any other operator in the State. They provided almost

800,000 trips last fiscal year and traveled almost 8,000,000 miles. They have a diverse fleet of over 200 vehicles and maintain transit facilities in several counties. This transit system has taken unused shells of buildings and, through transit, have turned them into something productive and useful for the entire community. This includes the renovation of an empty building that has become a cafeteria for their employees and the public. Their maintenance and security procedures are second to none.

RTEC is a Human Service Transportation Delivery (HSTD) Broker. They also provide valuable employment transportation and transportation for persons with disabilities. Their intercity services allow their rural citizens to access Greyhound in three (3) different cities.

RTEC is near the top every year in almost every category, from DBE purchases to ridership and mileage improvements. They remain in the forefront of serving their communities. Their Veterans Transportation Initiative should become a shining light for this State. They are committed to equal access with regard to employment and with regard to their services. They are also the third largest EMPLOYER in their home county.

OUTSTANDING STATEWIDE SECTION 5310 SPECIALIZED TRANSPORTATION **PROVIDER**

Pennyrile Allied Community Services, Inc. (PACS) operates a fleet of over 80 vehicles in nine counties serving the transportation needs and quality of life needs of the elderly and persons with disabilities.

While the of percentage of Elderly in the United States is 13.7% and the percentage of Elderly in Kentucky is 14%, the average percentage of Elderly in these nine counties is 17% with a high rate of 22%. PACS serve over 5,000 unduplicated persons for outreach, information and assistance, homemaking, escorts, congregate meals and meals on wheels. They provide the most trips under Section 5310 annually in the Commonwealth – over 200,000 trips. They provide these trips while also providing public transportation and being the HSTD Broker in the area. PACS is now reaching out to the Veterans and their families. They are proud that their service area covers Fort Campbell and are reaching out to the active military as well.

This award is also an opportunity to honor Twana Johnson, their long-time transit manager who is retiring at the end of this month.

OUTSTANDING JOB TRANSPORTATION

Jobs...Jobs... That is the big topic in today's news and in today's economy. We are recognizing a system that is really trying to do something about it.

In a county with an unemployment rate of over 11% and three (3) points higher than the State rate, this public transit agency is providing valuable transportation services to jobs and job-related activities such as interviews, training, GED classes and college classes. Federated Transportation Services of the Bluegrass, Inc. (FTSB) is taking citizens of this rural county to where the jobs are and many times they are transporting outside the county to larger communities and even out of State, places such as Maysville, Morehead, Ashland, and Portsmouth, Ohio. All vehicles are lift-equipped. This service is not only for persons without cars, but for all persons who want to save on gas and help the environment. The service has provided over 8,000 job or job-related trips the last two years and has operated over 500,000 miles the past two fiscal years. They begin services as early as 4:00 am and run as late as 10:00 pm for the convenience of their riders. Services have been extended to other parts of the county. Riders can also be picked up at a sheltered park and ride lot.

FTSB will be extending job-related transportation services to include three (3) more rural counties. This system will also make a special effort to make these services available to our Veterans and Active Military.

With larger, more comfortable vehicles and the latest in technology, the citizens in this very rural county have been given options and a chance at a better life. Because of the valuable, lift-altering services provided to Vanceburg and Lewis County through L'Trans.

OUTSTANDING INTERCITY MEANINGFUL CONNECTIONS AWARD

Providing accessibility and mobility to the citizens of the Commonwealth is one of the most important objectives of public transportation. In our rural areas, another objective is to support the connection between nonurbanized areas and the larger regional or national system of intercity bus service in order to give rural citizens access to more distant points. Many of our rural systems have taken this objective to heart and are endeavoring to develop or improve their intercity connections.

TANK's Florence Hub opens with new service

Grand opening and Ribbon cutting held on October 29

Service to the new Transit Authority of Northern Kentucky (TANK) hub at Mall Road and Heights Boulevard began on Saturday, Nov. 2, following a nine-month construction project to build the facility.

On November 2, the #1 Florence/Industrial route started service to the Florence Hub and on Monday, November 4, TANK began offering direct, fast, express service to downtown Cincinnati via a new bus route, the #42X.

To celebrate TANK's second Northern Kentucky suburban hub, TANK offered free rides on the Route #42X from November 4 through 8th.

The new hub serves two purposes – a park and ride for up to 150 cars and a transfer point between routes.

"The hub allows people to begin to travel between routes without having to go into Covington and downtown Cincinnati to make a transfer," TANK General Manager Andrew Aiello said. "This change will save time for our customers that are used to having a much longer bus ride to make this same trip. This effect will be amplified as more and more Boone County routes begin to stop at the hub."

The Florence hub was a development project that came out of the 2007 Transit Network Study. The Network Study report identified the concept of suburban transit hubs as a way for TANK to begin changing the way we operate the currently mostly hub and spoke system. Transit hubs that allow

CTAA Conference June 8-14, 2014 St. Paul, Minnesota The Twin Cities Expo people to transfer out of the downtown area will make suburban to suburban travel more convenient and much faster for potential passengers.

The Florence hub is the second of four transit hubs that TANK is constructing in suburban

Northern Kentucky as part of a recommendation from the 2007 study. The first suburban hub is in Fort Wright near TANK's main garage on Madison Pike. The next hub will be located at Northern Kentucky University. These locations join the

Covington Transit Center as focal points for TANK service in the community.

Florence is an important transit market for TANK...the Florence Mall and surrounding area in Boone County is one of the areas with the highest ridership in the system and with a large amount of both retail, commercial and industrial development.

Fulton County Transit Authority, in a particularly isolated area of the Commonwealth, has worked diligently with local officials, local communities and the Intercity Bus Industry in setting up true intercity services. They have interlined with Miller Trailways to be a bus ticket sales agent. This agency advertises and sell bus tickets for Greyhound and Miller Trailways to anywhere in the nation. Fulton County Transit Authority also serves as a feeder service to the Miller Trailways bus, which stops daily at their transit facility. They feed into the Greyhound bus station in Paducah for those unable to board the Miller Trailways bus at the transit facility.

One of the most valuable services this public transit agency provides is transportation to and from the area Kentucky Amtrak Station. They will pick up in their county and surrounding counties to deliver individuals to the Amtrak station. This system also provides free, secure parking for people boarding their transit bus to ride to the Amtrak Station. Ridership for this service has increased by 29% from FY 2012 to FY 2013. Here is just a sample of the comments received on their Amtrak service:

OUTSTANDING SECTION 5311 PUBLIC TRANSIT SYSTEM FOR CENTRAL KENTUCKY

Louisville WHEELS Transportation, Inc. operates in six (6) rural counties with a fleet of over 70 vehicles. They have state of the art transit facility and maintenance garage with state of the art security. They provide around 120,000

trips and travel almost 1.5 million miles annually. Over 44% of trips provided are trips for individuals in mobility devices. Cameras, MDTs, new radios, new dispatching and scheduling software have helped this system continue to provide safe and valuable public transportation services. While expanding the transportation options for their region, they serve the mobility needs and improve the lives of the rural public, elderly and individuals with disabilities.

Their regular route Intercity service has become a model for the rest of the State. Ridership on this route increased by 54% in FY 2013 over FY 2012.

After a thorough analysis and a tougher safety policy, this agency also reduced at-fault accidents by 47%.

This transit system has been a vital part of the region for decades. The Executive Director and his staff have made many personal sacrifices with their own time and their own resources in order to maintain operations at a high level. This is a transit system that has reached out to other transit systems and provided public transit expertise and advice to transit systems throughout the State.

OUTSTANDING SECTION 5311 PUBLIC TRANSIT SYSTEM FOR WESTERN KENTUCKY

Audubon Area Community Services and Green River Intra-County Services (GRITS) are a Human Service Transportation Delivery Broker and a Complimentary ADA Paratransit Provider. They operate deviated fixed routes, intercity and demandresponse services. They have their hands in many fires and are a valued member of their community.

GRITS has been ahead of its time with their infrastructure by recognizing that purchasing low-floor vehicles, vehicles with wider and heavier lifts, and purchasing a 10-position bus better accommodates their area needs. They have also constructed a "green" facility garage that recycles oil, tires, filters and utilizes an environmentally friendly HVAC system. They also rent out bicycles to help alleviate congestion and pollution.

Dan Lanham, Transportation Director of Grits is involved in many activities to benefit the entire state. He and his system have been invaluable partners to the State during the last two (2) years as major transitions have taken place. But this system never

OUTSTANDING SECTION 5311 PUBLIC TRANSIT SYSTEM FOR EASTERN KENTUCKY 2013

Daniel Boone Community Action Agency operates in multiple mountainous counties with a diverse fleet of over 100 vehicles. This agency has as a modern Transit Facility and Garage set upon a mountain with one of the most stunning views you will ever want to see. They provide over 200,000 trips and travel over 2 million miles annually.

With their demand-response services, they provide public, non-emergency medical and in this high unemployment area, offer valuable transportation to jobs and training. Intercity services connect to Greyhound in three (3) cities. While the poverty rate in Kentucky is 16.9%, the poverty rate in this area averages over 29%. This transit agency is aware of this fact and provide transportation for basic needs at an affordable fare.

Knowing the needs and problems in their own region, this system has taken on the job of going beyond the USDOT/FTA Drug Testing Requirements and are requiring testing for additional illegal and prescriptive substances that are a particular problem in their area.

This system is a consistent partner and valuable member of the public transit community. They can be relied upon by their communities and by the State to continue to provide these invaluable services no matter the weather, no matter the economic turn, no matter the terrain, no matter anything.

OUTSTANDING STATEWIDE PUBLIC 2013 TRANSIT MANGER

This system provides transportation for Housing Authorities and transportation to social service organizations and works with the local educational institutions. Both Local and State officials know they can count on her and do not hesitate to give her their support.

Under this Manager – and running over two million miles annually – the 80 fleet system provides approximately 140,000 trips annually.

This manager and her transit agency provide diverse transportation services from public, non-emergency Medical, New Freedom, Jobs, Intercity and Dial-A Ride. Additional work is gladly received.






















KPTA presents awards during 2013 conference

transportation. Under her guidance, public transit now provides over 29 million passenger trips annually in both rural and urban areas. These trips provide Kentucky's citizens with access to jobs, shopping, education, medical services, etc.

Even before the Federal mandate for all Federal programs to coordinate their transportation services, Bourne worked with the Department of Medicaid Services and key legislators in coordinating and linking human service/Medicaid transportation needs with the Transportation Cabinet's transportation resources. Bourne was appointed by then Governor Patton to serve on the initial Empower Kentucky Committee that worked on the details of a coordinated human service transportation system. Bourne helped write the laws and administrative regulations that authorized and still oversee Human Service Transportation and other public transit programs.

In 1998, soon after the incorporation of nonemergency Medicaid transportation and the development of the Human Service Transportation Delivery Program, the public transit section of the Division of Multimodal Program (formerly Mass Transportation) was pulled out to become the Office of Transportation Delivery. On November 1, 2001, Bourne was appointed the Executive Director. The coordination, safety, and cost-savings associated with the Human Service Transportation Delivery Program (HSTD) has become a model for other States and has received national recognition in national media (CSPAN) and in transportation research publications. The HSTD program not only has saved the Commonwealth millions of dollars, it has increased the reliability and safety of the transportation services provided to our eligible Medicaid recipients and now provides over three million non-emergency medical trips annually.

Kentucky was recognized for being the first State in the entire nation to have an ARRA (American Recovery and Reinvestment Act of 2009 Stimulus) public transit grant awarded. Bourne applied for these funds as soon as they were announced in order to help improve Kentucky's public transit infrastructure and to help provide needed jobs. Through the efforts of Bourne, Kentucky has once again been awarded two nationally competitive grants in the amount of \$1,655,927 for transportation improvements. These new grants, through the Veterans Transportation and Community Living Initiative, will work within the Office's Human Services Transportation Delivery

Program to enhance and coordinate access to local, affordable transportation services for veterans, the military, their families and spouses, and our wounded warriors. In the first round, the Kentucky Transportation Cabinet (KYTC) competed with 70 other proposals around the country representing \$52 million in funding requests and was one of the 55 awarded projects totaling \$34.6 million. In the second round, KYTC competed with 81 other proposals around the country representing \$41 million in funding request and was one of the 64 projects totaling \$29 million.

As the Regional Administrator for USDOT/
Federal Transit Administration Region IV stated in
her praise of Bourne and Kentucky, "Kentucky gets
it." Under Bourne's leadership, Kentucky Public
Transit has accomplished an almost impossible feat—
nine years in a row with zero deficiencies found
during three Federal Transit Administration (FTA)
intense, on-site reviews covering 27 different areas.
Bourne was voted one of the first three inductees
into the Kentucky Transit Hall of Fame in 1999.

Bourne, throughout her career, has always been the first to arrive at work, rarely taking breaks or full lunches. Public Transit agencies and Federal officials all have her cell phone number and know that they can (and do) call her on any day or at any hour. FEMA even called her on a Sunday to get an assessment of the ice storm disaster in Kentucky in 2009. She stayed in touch with them throughout the crisis. She is truly a "working" Executive Director that is willing to do any job required, whether it is meeting with government or legislative officials or just stuffing envelopes. She will do whatever is required to get the job done, always keeping in mind that we represent the Cabinet and work on the taxpayers' money.

Other States are frequently seeking information and advice from Bourne. Beecher Hudson, President of the Kentucky Public Transit Association, has traveled all over this country and he states that other State Transit associations want to know how Kentucky's association gets along so well with our State DOT. "My answer is always - Vickie Bourne - because she loves the transit agencies in the State and she treats us like a family."

Bourne still lives in Owen County where she and her family are active in the community. She has been married to Mark Bourne for 40 years and has a married daughter. She is now very proud to be called, "Nana."
