## Payroll Tax Bill Signed - TANK Funding Preserved

Governor Ernie Fletcher signed HB 400, a bill designed to preserve the current levels of revenue generated by the payroll tax in Kenton and Campbell Counties.

Payroll tax revenue in Kenton and Campbell counties was in jeopardy as a result of a Kentucky Supreme Court decision rendered November 18, 2004 related to occupational license fees. The payroll tax provides money to operate TANK bus service in Northern Kentucky. TANK worked

with the local business community (led by the Northern Kentucky Chamber of Commerce), along with the Campbell and Kenton County Fiscal Courts to remedy this situation in the General Assembly.

By a strong margin, members of the Kentucky Senate and Kentucky House of Representatives each gave approval to HB 400 (Draud/Fischer) preserving the current levels of revenue generated by the occupational license taxes collected in Kenton and Campbell Counties. The Northern Kentucky Caucus members all voted "yes" for

The General Assembly just passed an off year budget that includes Tax Reform. The General Assembly approved \$5.2 million annually in General Fund Revenue for the State's transit programs. Here's the breakdown of the Public Transit budget.

# Bailey resigns as Secretary of Transportation

*Governor Ernie Fletcher announces Transportation Cabinet Secretary  
is moving to Emergency Management*

*Maxwell "Clay" Bailey to direct Emergency Management;  
Bill Nighbert named acting Transportation Cabinet Secretary*

Governor Ernie Fletcher announced the resignation of Maxwell Clay Bailey as Secretary of the Kentucky Transportation Cabinet. Bailey will become the new Director of the Department of Emergency Management.

"Clay Bailey has an exemplary record of service as Secretary of the Transportation Cabinet," said Governor Fletcher. "Under his leadership, Kentucky has made great strides toward meeting my administration's goals of a safe and reliable transportation system that leads to economic opportunities. I am confident Bailey will meet his new challenges in Emergency Management with the same vigor and determination as he exhibited in the Transportation Cabinet."

Governor Fletcher appointed Maxwell Clay Bailey as Secretary of the Kentucky Transportation Cabinet in December 2003 and tasked him with bringing efficiency and better business practices to the Transportation Cabinet. In the first year alone under Secretary Bailey's leadership, the Transportation Cabinet realized cost savings of \$74.5 million through greater control over change orders and reducing other costs like overtime and the amount spent on asphalt.

"I'm proud of the accomplishments our Cabinet has realized in the last 15 months, and I am confident based on the vision of Governor Fletcher, and the quality of employees we have, the Transportation Cabinet will continue to work toward improving business practices and bringing more savings to the taxpayers of the Commonwealth," Bailey said.

Before being appointed as Transportation Secretary, Maxwell Clay Bailey spent 32 years

with the United States Air Force as a Lieutenant General, retiring in March 2002. General Bailey's last assignment in the Air Force was Commander, Air Force Special Operations Command, where he oversaw the deployment of special operations forces in Afghanistan during Operation Enduring Freedom. After his military service ended, Secretary Bailey developed programs to assist Kentucky law enforcement agencies with Homeland Security through the Department of Criminal Justice Training.

"Secretary Bailey informed me he wanted to resign as Transportation Secretary in order to be considered for the position at Emergency Management," continued Governor Fletcher. "His extensive military experience makes him the ideal person to run the state's Emergency Management operations. I'm confident he will do an outstanding job and the people of Kentucky can take comfort in the fact that we have someone of Clay Bailey's caliber in charge of Emergency Management."

Bill Nighbert becomes acting Transportation Secretary. Nighbert currently serves as the Transportation Cabinet's Commissioner for the Department of Intergovernmental Programs. Nighbert has also served as the Deputy Commissioner for the Governor's Office for Local Development (GOLD). Before moving to state government, Nighbert served three terms as the mayor for the city of Williamsburg. The search to fill the cabinet position of Transportation Secretary begins immediately. Secretary Bailey's resignation from the Transportation Cabinet is effective today.

## Kitchin introduces Mobile Drivers Training Center

Gary Kitchin, Paducah Transit Authority, introduces his Mobile Drivers Training Center at the January 2005 KPTA meeting.

The simulator will create a driving environment from equipment failure to hazardous weather conditions. The driver will be able to learn how they should have reacted to the different situations.

This training will consist of six to eight hours of classroom training and over the road training.

The center is housed in a 53 foot mobile tractor trailer with six classroom stations and three state of the art driving simulators (includes one bus simulator and two simulators for cars, vans and cut-a-ways).

The curriculum will consist of the following:

- Basic Defensive Driving (new drivers and experienced drivers)
- Severe Weather Driving (snow, sleet, rain and fog)
- Equipment Failure (blow-out and steering malfunctions)

■ Accident Retraining (accident reconstruction).

The training cost will be \$50.00 per driver if you are a KACO client. If you are not insured by KACO the cost will be \$125.00 per training.

# Lexington's Transit Authority upgrading services

Thanks to community support through approval of a tax referendum last year, Lexington's transit authority is in the process of expansion, route improvement, and upgraded service. Among the improvements is re-instatement of Sunday service and late night routes beginning in May, 2005.

"We are very excited about being able to provide these needed services once again to our riders. And more improvements will be phased in over the next year-and-a-half, including bus service every thirty minutes for most routes during peak usage times, and ultimately 30-minute service on all routes," said Terry Garcia Crews, LexTran's general manager.

Included in expansion plans will be the purchase of additional buses and the hiring of more drivers. These changes stem from a major efficiency and operational study conducted by R.L.S. and Associates, of Dayton, Ohio. Resumption of services is the result of voter approval of property tax increases which will result in more than \$11 million for LexTran.

"System improvements follow many months of intensive review and data collection, along with input from our riders and the community. This information determined where routes should travel, and is part of LexTran's commitment to improve and streamline, garner effectiveness, and provide necessary community coverage," added Crews.

On Sunday, March 6, 2005, Sunday service was restored, and beginning May 8, 2005, late night service will resume, until 11:20 p.m. Some consolidation of routes during the final three trips of the evening will occur. Routes will run on an hourly basis, with two of the higher-use routes upgrading to service each half-hour. Nine new buses will be purchased and LexTran is planning to hire 46 additional drivers. Also in the planning stages are bus facility renovation and expansion, which would be made possible through acquisition of federal funding.

Paul Maxwell, former Fulton County Transit Authority operation's manager, is serving as the Interim Executive Director.

Maxwell said, Fulton Transit will continue to move forward with the growth and community service that has come to be expected by the residents of Fulton County.

# New trolleys and new image keep downtown rolling

New TARC trolleys and a new image will make it easier and more fun to get around Louisville's booming downtown. TARC, with the support of Metro Louisville Mayor Jerry Abramson and \$2 million in federal funding secured by U. S. Rep. Anne Northup, Sen. Jim Bunning and Sen. Mitch McConnell, put five new trolleys into service on April 1, along with a campaign to promote ridership.

"TARC's trolleys play an important role in revitalizing Louisville's downtown area. They help promote the city to tourists, contribute to economic development, and are a lot of fun for local residents and school children. I'm glad to help support this Louisville tradition," said Congresswoman Anne Northup.

TARC's downtown trolley routes will be color-coded as of April 1 with better signage and more information at the trolley stops. The Fourth Street Trolley, the original route that travels from Theatre Square to the Galt House Hotels, will have green signage.

The Main and Market Street Trolley, which loops from 10th street to Wenzel on Main and Market Streets with a jog south to the Kentucky International Convention Center and Fourth Street Live, will be distinguished with red signage.

Both trolley routes will continue to charge a 25¢ fare.

The new trolleys will also be used for the First Friday Gallery Hop and the Frankfort Avenue Trolley Hop, also known as FAT Friday.



# TARC receives second federal Access to Jobs Grant

With a \$ 1.1 million federal grant awarded by U.S. DOT under the Job Access and Reverse Commute Program, the Transit Authority of River City (TARC) in Louisville, Kentucky, will be able to build on the success of its first-year appropriations of job access services and continue to help citizens in greater Louisville access employment sites. This is the second federal grant issued to TARC for welfare-to work issues.

TARC plans to develop several new programs and enhance existing programs designed to provide greater access to employment opportunities and promote economic growth in greater Louisville.

Grant funds will be targeted to several new initiatives that include developing new transit services to employment sites in Jefferson County and emerging job centers in Oldham and Bullitt counties; targeting customers who speak Spanish, Russian, and Bosnian languages; developing a map showing licensed child care facilities in relation to TARC fixed route services; and developing transportation options for public school students.

In addition, TARC will build on existing programs, including continue Night Owl service; continue and expand suburban/urban connectors; expand UPS-related services; and expand Job Hunter Bus operation.

- Facility modifications that improve access, improve appearance, and allow people to become more proud of their environment.
- Worked to successfully pass interim legislation which allows TANK to continue operating its existing level of service.
- Development of a new Strategic Plan that serves as a business plan to guide management efforts.
- Movement towards service coordination with other agencies providing transportation, to improve the effectiveness of all transportation in the region.

"The board wishes to express its gratitude to David for his efforts during his time at TANK and wish him continued success as he takes on his new assignment" said Malone. A national search has been initiated by First Transit and the TANK board to seek out candidates to fill the general manager position.

Braun will continue to live in Boone County with his family.
