



KPTA To Hold Information & Training Sessions

On the opposite year of the Association's conference, KPTA sponsors a training session which is given by a nationally known instructor. This year's training program, which will be held on Friday, September 16, is *Practical Financial Management for Non-Financial Managers*.

This training will cover the following topics:

- establishing financial policy;
- basic accounting concepts;
- developing financial statements and reports;
- budgeting techniques;
- basic cost allocation principles;
- the role of internal versus external financial reporting;
- financial analysis;
- generally accepted accounting procedures;
- the auditing process;
- asset and liability management; short and long range transit financial problems and potential solutions;

On the first day of the meeting (Thursday, September 15) we will have three separate sessions:

- The first session will cover funding and coordination, including Medicaid and Title III. Several changes have taken place with regard to non-emergency medical transportation and others may take place regarding Title III.
- The second session will cover the process by which a professional

MRO service can be recruited and contracted with to handle your company's drug testing. We will also look at the reporting process which will be required for both drug and alcohol testing.

 The third session will be the KPTA general membership and Annual Meeting.

Transit System Spotlight – Green River Intra-County Transit System (GRITS)



This month we go back out west to Owensboro, Kentucky to spotlight The Green River Intra-County Transit System, which is a service of Audubon Community Services.

I spoke to Buddy Fuqua, transportation manager for GRITS and current KPTA president about how the system began and how it has changed over the years. It was interesting to find out that Buddy and his family have been in transportation for quite some time. Fuqua Bus Lines once rolled down the streets of Owensboro and the roads to Indianapolis. Buddy said that his family sold the business just a couple of years before ICC deregulation. As he looks back, that was a good move.

Buddy came to GRITS in 1977 as the manager for the newly formed service and went right to work. He has watched GRITS grow from a system with a hand full of vans with few service hours to a system with over 24 vans and buses operating seven days a week. The service has changed right along with the number of vehicles. GRITS provides a demand response service in the counties of Davies, Hancock, Henderson, Ohio, McLean, Union and Webster, as well as the paratransit service for the Owensboro Transit System.

Many people have commented about the system's name, so I asked Buddy what enthused someone to call a transit system GRITS. He said that when the system started, their was a planner who worked at the Green River Area Development District who wanted to give the system a catchy name. So after much contemplation she came up with the Green River Intra-County Transit System. Her name was Tonya Grits.

The Cabinet's Corner

New Name

As most of you already know, the Division of Mass Transportation is now the Division of Multimodal Programs. This was effective July 15, 1994 as the result of the reorganization of the Transportation Cabinet. The Division of Multimodal Programs is under the Office of Intermodal Planning within the Department of Highways. The Division will also be moving to new offices. The tentative date for this move is October 15, 1994. The new address will be announced at a later date.

Alcohol & Drug Training

The Federal Transit Administration's (FTA) Implementation Manual for Drug and Alcohol Regulations in Mass Transit is now being printed and will be distributed at the upcoming statewide Drug & Alcohol training (not the KPTA training) to be given by the Division of Multimodal Programs. The date(s) for this training will be announced before the end of September.

After this training is held, regional training will be given by the Cabinet on *Reasonable Cause Drug and Alcohol Testing*. This will be accomplished with an interactive training program developed through FTA. This training consists of VHS Videotapes and a Discussion Leader's Guide. The training package will be distributed at the session(s).

The Multimodal Programs division is receiving periodic guidance from FTA regarding the Drug & Alcohol Regulations. Technical Amendments and changes are being executed. Please contact the Division if you have questions.

Maintenance/Operations

A mass mailing concerning contractor maintenance/operations will be forthcoming to all Section 18 and Section 16 agencies. A recent audit on operations and maintenance of FTA funded buses by contractors under contract to grantees revealed that in some cases the contractors were not performing the required preventive and other maintenance in a thorough and timely manner.

Codification

Public Law 103-272 changed the statutory scheme of FTA's State formula assistance program as follows:

- (1) The formula assistance for elderly persons and persons with disabilities is now codified at 49 U.S.C. Section 5310, and Section 16 of the Federal Transit Act, as amended, 49 U.S.C. app. Section 1612 has been repealed; and
- (2) The Formula assistance program for nonurbanized areas is now codified at 49 U.S.C. Section 5311, and Section 18 of the Federal Transit Act, As amended, 49 U.S.C. app. Section 1614 has been repealed.

A Couple of Things to Note

Mass mailings have gone out to all Section 16 and Section 18 agencies regarding the following: FTA's decision to allow Section 18 systems to provide Head Start Transportation; The annual process necessary to provide charter service; The correct procedure for reimbursement or approved capital and RTAP expenses; Bus testing program status and regulatory requirements; and, issues concerning the sub-contracting of services and operating authority.

Transit Authority of River City Ranks Among the Best

TARC's operating expense per passenger trip was just 76% of the national average.

A study was conducted by the University of North Carolina at Charlotte, to research transportation efficiency. The Center of Interdisciplinary Transportation Studies, reviewed the costs of usage of 102 of the nations largest transit systems over a four-year period and found TARC to be the third most cost-effective. Louisville's system ranked in the top ten in each of the four years studied.

Some of the study findings were that: TARC's cost effectiveness is the result of low operating costs and high area coverage; TARC's operating expense per passenger trip was just 76% of the national average; and that TARC's ridership, when compared to Louisville's population was twice the national average.

How did they do it, you might ask. According to the study they, kept their fares low to encourage ridership, serve markets that will yield the greatest ridership, provide compact service coverage, keep costs low and subsidies to a minimum.

Some Medicaid Business May Go Out To Bid

According to an August 1, report from the Associated Press, Masten Childers, Secretary for the Cabinet for Human Resources, has submitted a request for a waiver to the Department of Health and Human Services that would allow the Commonwealth to seek competitive bids for transportation in areas where fraud is suspected.

Last year the state spent \$26 million on Medicaid trips. \$13.5 million was for non-emergency.

ADA Revision Notice of Proposed Rule Making is Published

The Department of Transportation published an NPRM on July 21, 1994 that could change several aspects of the Americans with Disabilities Act.

In brief, the proposed rules would:

- Allow fixed route systems to choose which bus stops at which they would pick-up and drop off passengers with disabilities because of terrain;
- Change the requirements affecting certain private schools that provide

fixed route transportation;

- Eliminate the paratransit requirement which affords passengers 14 day advance booking of trips;
- Eliminate the full process of submitting paratransit updates if a system is already in compliance.

The High Cost of Stress

Fortune Magazine calls the 90's the Age of Overwork. The United Nations International Labor Organization considers stress to be the 20th Century disease. INC Magazine recently quoted the CEO of a major corporation, "at every level of the organization...the big concern is stress. We are working overtime because we don't want to add to payroll. Our salespeople are pushed to the limit. We are a very, very successful company, and yet I wonder how long we can go on like this. How long can I go on?"

The number of people who consider their job highly stressful has more than doubled since 1985, according to Health and Human Services and Northwestern National Life of Minneapolis. According to another poll, only 4% of workers consider their jobs relatively free of stress, and at least one in seven is considering quitting because of the stress.

What one person considers stressful, however, another may consider challenging. When stress becomes an inherent part of a job, long term productivity requires that the job description be modified, compensation be adjusted, or both.

If stress is short term, it can be absorbed by most people. When it is a way of life, it is a time bomb that portends serious injury to all affected parties. The International Labor Organization estimates that stress costs U.S. industry \$200 billion a year in diminished productivity, increased workers' compensation claims, higher rates of absenteeism, and medical expenses. As managers have become aware of these costs they have begun to look for ways to address the problem.

Human Service Transportation Evaluation Workbook is Available



Becoming a rogue in his later years, Dumbo terrorized the world's flyways.

For many agencies throughout the Commonwealth, coordination of transportation among transit systems and human service agencies is a difficult process to begin, implement and maintain.

The Center for Urban Transportation Research for the Florida Transportation Disadvantaged Commission has formulated an evaluation workbook that can be used by either a transit or human service agency to give a base by which to work toward coordination. Some of the information is only applicable to Florida, which requires coordinated transportation.
