
From The Desk of The President

The following are new changes for NTS:

- NTS can send bills to your agency by email, fax, or mail. E-mails will be sent in the PDF/Adobe Acrobat format to be printed for your files and records.
- On February 1, 2002, check for new NTS forms when an employee from your agency goes to a collection site. It is important not to confuse the old chain of custody forms you have with National Safety Alliance with the new forms NTS will provide to you. The USDOT and Non-federal custody and control form will be mailed directly to you by NTS. You have two options: 1) maintain the forms on your site and distribute per each test; 2) or mail a supply to your collection sites.

• As required by federal regulations, MRO certifications must be on file in your office. Please find enclosed NTS Certification for the MRO requirement.

NTS can help provide backup or additional information for Substance Abuse Professional (SAP) referrals. An additional cost would be incurred. The website is www.drugtest.info.com. You are reminded to have a SAP contact and certification file in your office.

• New Prices:

Prices shall be at the guaranteed prices of forty-six dollars and fifty cents (\$46.50) per drug test and thirty-five dollars (\$35.00) per alcohol test.

Additional Costs

- ✓ Split specimen testing shall be one hundred and fifty dollars (\$150.00) per requested test;
- ✓ Soap test, or other esoteric adulteration requested by MRO, shall be one hundred dollars (\$100.00);
- ✓ Special handling fees over and above regular collection site fees shall be passed through to CONSORTIUM MEMBERS for after hours or on-site services;
- ✓ D/L Isomers (if needed on some methamphetamine positives), shall be one hundred dollars (\$100.00) per instance;
- ✓ Post accident collection will be at cost, and Post-Accident and Reasonable Suspicion Specimen Collection and Breath Alcohol Test Provider Identification Assistance shall be one hundred dollars (\$100.00) outside of normal business hours.



TANK begins special bus service for NKU Students

Transit Authority of Northern Kentucky (TANK) kickedoff a new service for students at Northern Kentucky University on January 10, 2002. The new route, penned the "NKU

River Run", will offer students a fast trip to the rapidly developing Kentucky side of the Ohio River to visit the many attractions for job opportunities as well as fun. As an incentive to try the service, the first weekend was free to students, compliments of NKU's Student Government Association.



The River Run will stop at the University residential village and then head directly for a stop at the area's newest attraction: Newport on the Levee. With a 20-screen movie theater, IMAX theater, Shadowbox Cabaret live entertainment, retail, restaurants and nightlife now open, this new entertainment complex will serve as a main destination for the students.

From the Newport on the Levee stop, the route will continue to Covington where stops will include Covington Landing, the Waterfront restaurant complex and the historic MainStrasse Village. In addition, students can transfer onto TANK's Southbank Shuttle and travel into Cincinnati at many of the NKU River Run stops.

Students and faculty at NKU have seen a need for this type of service growing on their campus for several years. With enrollment rising and the residential village at full occupancy, students are spending more time on campus and many are without personal vehicles.

Students from NKU's Student Government Association, several fraternities and sororities and the residential village helped demonstrate the need for the service, assisted with route design and selecting a name for the service and are helping to promote the service on campus. University staff have supported and encouraged the concept as well.

"This is a great opportunity for college students to learn about and use a convenient public transit service. We are pleased to have been able to customize a route that the students feel will meet their needs and fit their lifestyle," said TANK General Manager Mark Donaghy. "I hope that this opens up other opportunities to serve the university population in the future. The NKU River Run will play an important role in the continued success of our riverfront venues and help draw this market to the river for jobs and entertainment, while promoting safety and responsibility among the campus population."

NKU River Run will operate from 6:00 p.m. to 2:00 a.m. every Thursday through Saturday. The cost for the NKU River Run is the same as the regular TANK fare, \$1.00 each trip. For details about the service, call 859-331-TANK (8265).

LexTran Reports Year End Ridership Results

The Lexington Transit Authority (LexTran) reported a 15% ridership increase for their fiscal year ending June 30, 2001. The public transportation system carried 4.5 million passengers this fiscal year, compared to 4 million in fiscal year 2000. Currently LexTran's average annual weekday passenger trips are 15,178 with weekend passenger trips averaging 5,191. The Russell Cave/Nicholasville Road Route carried over 900,000 passengers this year and averaged 51 passengers per hour of service. Overall the


system averaged 26 passengers per hour.

Increases in ridership have occurred steadily since 1994 when LexTran, increased frequency of service to 30 minutes during peak periods and 60 minutes off-peak, made minor route changes in and around the University of Kentucky, and began aggressively marketing the system.

In 1994, LexTran carried 1.3 million passengers, 1.8 million in 1995, 2.3 million in 1996, 2.6 million in 1997, 2.9 million in 1998, 3.7 million in 1999, and 4 million in 2000.

Bus Service to Connect Stanton and Winchester

A new shuttle service, called TransCity, will be a reliable form of public transportation for Powell and Clark

County residents.
TransCity will offer set routes on a regular bus schedule

necting Stanton and Winchester. The service is open to anyone needing a ride between the two cities. The service began in October.

The service will run Monday through Friday.

Partners for Public Transportation awarded grant

Partners for Public Transportation received a \$5,000 grant from the American Public Transportation Association (APTA). APTA's local Transit Coalition grants are intended to raise awareness of transit issues and build support for reauthorizing the federal Transportation Equity ACT (TEA-21) in 2003. With the passage of TEA-21 in 1997, Congress substantially increased federal investment in transportation.

Key successes include:

✓ \$171 billion for highways and bridges, an increase of more than 40 percent over the previous six years.

✓ \$41 billion for public transit, an increase of more than 30 percent over the previous six years.

KPTA encourages all members to join Partners for Public Transportation. There is no fee required, just fill out the registration and join in and support public transportation.

The Stanton-Winchester shuttle will cost \$3 one-way per person. A package of 10 trips costs \$25. The route will start in Stanton and have several pick up and drop off points in Powell County before traveling to Winchester. The route will include stops at various factories and locations in Winchester before returning to Stanton. The shuttle will make several runs a day stopping at various locations in both cities to best serve the community.

Kentucky River Foothills is hoping to get people to work on time in Stanton and Winchester and this will help to meet everyone's need. As the area grows it's more important than ever to build the infrastructure for public transportation.

Foothills was awarded a Federal Job Access Grant last year in the amount of \$470,000 to purchase vehicles to start a new city to city shuttle service. In June, Foothills received federal grant of \$207,520 to help provide the shuttle service. The money will be used to replace vans and buses in the existing fleet that have excessive mileage and are in need of repair. Currently the shuttle service consists of four 15-passenger vans.
