



KPTA Sets Agenda for the Upcoming Year

KPTA held its annual meeting on Thursday, September 15 at the French Quarter Suites in Lexington. The following selected points were adopted as agenda items for 1995:

- Update and modify existing drug testing programs to meet the new requirements and to include alcohol into the program;
- Write and promote a plan of action to establish a consortium for the public transportation community throughout the state;
- Strive to get regulations regarding payment for services and authorization clarified and followed;
- Promote the idea of a designated funding source for public transportation;
- Promote the concept of minimum training requirements for drivers who work for companies that receive any federal or state money.

Lextran's "Rap & Ride" Summer Youth Program is Success

Lextran announced that preliminary figures from the "Rap & Ride" promotion was an overwhelming success. There was a 53% increase in youth pass sales with a revenue increase of 126% over 1993. Additionally, the promotion had residual effects in overall ridership. Total ridership increased 11.8% in June alone which is approximately 12,136 riders.

The program, which is geared to the under-tapped youth market, was promoted by some very visible and ear catching commercials. The advertisements, which ran all sum-

mer, showed primarily teenagers showing enthusiasm about being able to get out of the house even if they were unable to drive. It was filmed in a music video format that has a rap song as its main theme. According to Steve Rowland, General Manager at Lextran, the teenagers in the video wrote the words to the song.

TARC has a New Executive Director



Governor's conference on Aging and the Pre-White House Conference on Aging Result in Similar Transportation Recommendations

Side note about the Pre-White House Conference

The transportation session at the Galt house was lead by Eddie Rivas, formerly of CTAA fame, where he was the Director of the Eldercare Institute's transportation resource office. Eddie is now the Senior Program Specialist for Consumer Affairs for AARP.

Eddie made it clear at the beginning of the session that he was an advocate for community transportation as well as mobility for the elderly. Eddie's role at AARP will bring about a new era for the Association in the field of transportation. AARP has been a long time advocate for drivers' issues, but now they are getting ready to help us in the community transportation arena.

The Association of Older Kentuckians' (A-OK) annual Governor's conference on aging was held at the Holiday Inn on Broadway in Louisville, September 21 & 22. This year's effort was promoted by the desire to obtain information to send to Washington D.C. for the White House Conference on Aging in May 1995.

One of the five topic areas to be examined was transportation. This is a perennial subject at the Governor's Conference, but this year the recommendations will hopefully have a little more impact because of the national purview the groups were assuming.

In years past, the recommendations from this conference centered around one topic - coordination of policy and funding. This year was not different. Transportation coordination was the number one recommendation. This was followed by a recommendation that congress should maintain, at least, current spending levels on federally funded transportation services.

The issues that seemed to prompt these two recommendations were very clear and distinct. Agencies that are protective of their turf are causing a reduction in available resources for all other agencies that are in the same area because of duplicated overhead and wasted trips. Also, the possibility of eliminating medical transportation payments with Medicaid and Medicare coupled with a never increasing dollar figure for Title III transportation has resulted in many people becoming very nervous about the future.

The transportation session had three challengers (Shirley Cummins, RTEC; Nikiforos Stamatiadas, University of Kentucky; Ned Sheehy, FTSB) to spark discussion about problems and recommendations within the topic area. The session was supposed to be split between two areas, drivers' issues and community transportation. However, the 60+ people present during the consensus building session were more interested in discussing community transportation, noting that drivers' issues should be resolved by states since they are the licensing entities.

The same findings were reported at the Pre-White House Conference on Aging held at the Galt House in Louisville on October 11.
Regulatory and funding coordination is of utmost importance. The consensus of the group was that adequate funding was in existence, but turf and ignorance of spending amounts promoted an inefficient group of providers.

Concerns were discussed about mandating regulatory and funding coordination because of the dangers of having a non-responsive entity become the sole contractor for an area. The group, therefore, decided to make the first recommendation that of setting standards of service that would be uniform.

The only other recommendation about community transportation that was addressed was one of appropriate rolling stock. A recommendation was made to allocate more money to help agencies obtain appropriate rolling stock instead of simply getting what their money will afford.

TARC and Dairy Mart Join Forces to Sell Fare\$aver Tickets

On October 5, the Dairy Marts in TARC's service area began selling Fare\$aver tickets. This marks the first time that a retail chain has become a ticket agent for the transit authority.

Since Dairy Marts are open 24 hours a day and 7 days a week, the ability for people to obtain a pass becomes even more convenient. The concept of bringing Dairy Mart into the fold will blend into TARC's PAY LESS and RIDE MORE promotion. A Fare\$aver ticket will allow bus riders to get nearly a 50% discount over regular fares.

This is not the first joint effort that TARC and Dairy Mart have entered into; next time your in the Louisville area, look for the bus that looks like a Dairy Mart store on wheels.

A Street Car Named Kentucky


TANK had a very unique delivery not too long ago - a 102 year old street car that once ran the commuter rails in Newport, Kentucky. The trolley was delivered to TANK from a park in Newport by Fender's Wrecker Service, which donated their services for the effort.

TANK's Maintenance Department will coordinate the refurbishment of the trolley.

To date, the motorized section and suspension has been cleaned and primed awaiting a final coat of paint. The metal work, including the brass fixtures and elegant iron railings, have been removed and await refinishing along with the windows and frames.

The "Streetcar named Kentucky" will hopefully be refurbished by 1995. Jim Seibert, Assistant General Manager for TANK says that they are hoping that they can restore the trolley to its original state. He also said that they will try everything possible to make the electrical engines operable again.


