

LexTran Expands Services to Nicholasville for Express Bus

LexTran's Nicholasville Express Bus Service that will begin operation on October 6 could save Nicholasville-Lexington Commuters \$2500 or more on the cost of their daily commute. According to figures received from Bluegrass AAA the 25 mile commute from Nicholasville cost the average commuter 55 cents per mile or \$13.75 per day. If a commuter bought LexTran's monthly pass at \$50 and used it for a 5 day/4 week commute he would save \$225 monthly or \$2700 annually.

This figure includes insurance costs, depreciation and depreciation for excess mileage, as well as ownership costs (financing, license, registration and taxes).

However, the operating costs (gas, oil, maintenance and tires) average 10.8 cents per miles or \$54 monthly. Plus, riders could get an insurance discount for not using their car for a work commute, they would save on depreciation, wear and tear, and their car would be worth more because of its low mileage.

Besides the money savings Nicholasville and surrounding area residents will arrive at work less stressed from their commute and may arrive ahead of the work day from the additional time they will have on the bus to begin their work day or simply read the newspaper. Finally, according to National Transportation studies Buses are the safest form of transportation so they may even save their own life or lives of loved ones by encouraging them to take the bus.

The new Express Bus Service will begin at 5:50 a.m. in the parking lot of the Nicholasville Wal-Mart. The Nicholasville Wal-Mart and LexTran officials have worked together to provide free parking in designated areas in the Wal-Mart parking lot for the commuter bus riders.

LexTran will provide commuter trips to Lexington from the Wal-Mart lot every half hour until 9:20 a.m. They will also make two trips around noon and provide half hour commuter trips again beginning in downtown Lexington at 4:20 p.m. The last trip to Nicholasville will begin at the Transit Center in Downtown Lexington at 6:20 p.m., arriving at Wal-mart in Nicholasville at 6:50 p.m. The Nicholasville Express will make 15 trips to Lexington from Nicholasville-eight trips in the morning, two mid-day, and five during the afternoon drive.

The Express bus will stop at Fayette Mall, Central Baptist Hospital and the University of Kentucky making it ideal for their employees. It will end at the Downtown Lexington Transit Center making it a convenient commute for those employed in downtown Lexington or riders can transfer to any LexTran route to complete their one-way commuter trip.

LexTran has been able to offer the Lexington-Nicholasville Express Bus Service through an agreement between the Lexington Transit Authority, The Commonwealth of Kentucky Transportation Cabinet, and the Lexington-Fayette Urban County Government. The Cabinet will provide money for the three projects with Federal CMAQ funds up to \$384,000. The Lexington-Fayette Urban County Government and LexTran will provide a local match of \$156,198 and fare box revenues are anticipated of \$80,000 with the total cost of the new route expected to be approximately \$207,000 per year.

The route is designated to lessen vehicle emissions and improve air quality in Kentucky's air quality non-attainment areas by providing transit service with limited stops to the approximately 50% of Jessamine County residents who work in Fayette County.


the Galt House. The ITA, KPTA, and Kentucky Transportation Cabinet awards were presented after the dinner. Photos of the winners are on pages' four and five.

On Thursday transit professionals were shown the process needed to make the transition from paratransit to

The speakers included: Susan Schruth, Region Director, FTA Region IV, James Hmurovich, Indiana Family and Social Services Administration, Joel Ettinger, Regional Director, FTA Region V, Doug Gereleman, Region V, and Barry Barker, Executive Director, TARC.

Ğereleman said improvements in coordination, setup coalitions and explore all the social services for money could help with the transportation problems.

Schruth expanded on the progress Region IV, including Kentucky, is making toward improvements in the transportation problems. She sees transit as a positive role for welfare reform in the future. As transit providers you need to listen to your customers. She said the future must consist of maximizing your transportation system to its fullest efficiency

The keynote speaker at lunch was Kip Banks from American Public Transit Association (APTA). William Millar, President of APTA was unable to attend because of a prior commitment. Banks said on September 4 Chairman Bud Shuster (R.Pa.) unveiled the bill reauthorizing federal surface transportation programs over three years. The Building Efficiency Through Surface Transportation Equity Act, known as BESTEA, cleared the Surface Transportation Subcommittee without any major changes. The \$103 billion highway and

transit bill provides \$17.6 billion for transit and preserves the program structure established under ISTEA. The current transit funding is at \$4.4 billion and is authorized to \$6.4 billion by FY2000.

New Tarc Trolley Hop to Serve Downtown, Frankfort Avenue and Bardstown Road

On August 30 and continuing for nine consecutive Saturdays through October 25, the clanging bells of TARC Trolleys will be heard along Bardstown Road, Frankfort Avenue, and Downtown Louisville as local residents, convention goers, and out-of-town visitors visit restaurants, art galleries, museums, and unique shops found along Louisville's most eclectic corridors.

Three trolley routes, all connecting at Lexington Rd. and Baxter (across from the Brewery), will run from 10 a.m. to Midnight. Trolley drivers will sell a \$3.00 all-day pass good for unlimited Trolley Hop rides, or customers can purchase a single ride for \$1.00; 1/2 price fares will be available for students, senior citizens, and people with disabilities with TARC I.D. cards. The Frankfort Avenue and Bardstown Road routes will operate every 20 minutes; the Downtown route will run every 40 minutes.

The Trolley Hop is funded in part by Louisville Gas & Electric Company and by more than two dozen businesses/attractions along the route. "This unique partnership shows that many diverse interests are committed to enhancing the quality of life in Louisville. The Trolley Hop will facilitate increased economic activity in a fun way that doesn't add to air pollution or traffic congestion," says TARC Executive Director, J. Barry Barker.

This nine-week Trolley Hop market test will be used to gauge ridership interest in this type of service. If successful, and additional sponsorship interest is generated, the Trolley Hop, in a similar or altered form, may run again during 1998.
