DISASTER RELIEF FOR MIAMI HURRICANE VICTIMS. Hurricane Andrew ripped through southern Florida destroying over 80,000 homes and leaving 200,000 people homeless or living in ruins. The employees of the Metro-Dade Transit Agency in Miami were among those who suffered great losses. Over one-fourth of the agency's employees were particularly hard hit - 300 of them lost their homes completely and another 300 had a high percentage of their homes destroyed. APTA is asking its members (KPTA is an APTA member) to lend a hand to our fellow transit workers by collecting funds from employees to be sent to the employees of the Metro-Dade Transit Agency. LEXVAN TO GET EIGHT NEW VEHICLES

The Lexington Bluegrass Ridesharing (LexVan) which is a cooperative effort between the Lexington Transit Authority and the Lexington-Fayette Urban County Government, received a grant for eight new 15 passenger vans from the FTA's Congestion Management and Air Quality Improvement Program (CMAQ).

The vans as spec-ed, will utilize an off center aisle which affords an easier passage to the rear of the vehicle by taking the wheel well out of the path. The new vans will also have an improved air conditioning unit and diffuser system which uses the headliner as the duct allowing each passenger to have their own diffuser.

One of the vans will be equipped with a ramp and wheelchair tie downs. The use of a ramp will enable the van to provide ambulatory passenger service until wheelchair use is needed.

While on the topic of CMAQ, according to APTA, Brian Clymer, FTA Administrator, stated that the project eligibility criteria have been clarified to provide that replacement bus purchases are eligible for funding under the CMAQ program.

ADA SELF-EVALUATION BY PUBLIC ENTITIES

The Americans with Disabilities Act contains a requirement for a "self-evaluation plan" to be prepared for public entities. Because this requirement has been extensively discussed or publicized, a reminder is made to "public entities" of the requirements. This plan is not required of non-profit agencies and is in addition to the ADA plan requirement for transportation. Contracts made with the disabled community in the development of ADA Paratransit Plans should be helpful since an opportunity must be provided to "interested persons, including individuals with disabilities, to participate in the self-evaluation process by submitting comments." Their input would be beneficial in helping with the process.

The self-evaluation is intended to help public agencies determine which programs and activities, if any, are discriminatory, and then make the necessary modifications to make them accessible. This has been a requirement under Section 504 for federal fund recipients. Only programs/activities not included in the 504 self-evaluation would need to be included in the ADA self-evaluation. Many agencies, however, may use this opportunity to reexamine all of their programs/activities. This plan does not have to be submitted to any agency, but must be made available for public inspection by January 1993 (available for three years for public entities that employ 50 or more people). The final rule covering Nondiscrimination on the Basis of Disability in State and Local Governments, 28 CFR part 35, contains the requirements for these plans. A copy of this final rule may be obtained from the DMT upon request.

We also note that if structural changes have been deemed necessary to achieve program accessibility that such changes must be made by January 26, 1995. For public agencies that employ 50 or more persons, a transition plan detailing the necessary steps to achieve compliance should have been developed by July 26, 1992. Again, interested parties should have been given the opportunity to participate in the development of this plan, and a copy should be available for public inspection. Requirements for the transition plan are also detailed in the Final Rule.

KPTA RURAL OPERATORS ROUNDTABLE

The newly formed Rural Operator Committee is organized under the guidance of KPTA. The Committee represents various transit related backgrounds from rural areas of Kentucky.

Ned Sheehy, Executive Director of Federated Transportation Services of the Bluegrass, Inc. (FTSB) is Chairman of the Committee, appointed by the KPTA Board of Directors. Other members of the Committee are Paula Kirchbaum, from Central Kentucky Community Action, Ray Young from Maysville Transit, Ned Colcord from Barren River Local Officials Organization, Pat Puckett from Fulton County Transit, and me, Shirley Cummins from RTEC.

The Committee met for the first time on August 27, 1992 at the RTEC Conference Room in Mt. Vernon, to devise the structure of the Committee and set the stage for the first KPTA rural operators roundtable.

The first roundtable meeting will be held in October.

TRANSIT SYSTEM SPOTLIGHT

FULTON COUNTY TRANSIT AUTHORITY


Fulton County, the most western county in the Commonwealth, saw the need for a transit system in 1985. With the help of local officials from both Kentucky and Tennessee and funding from the Division of Mass Transportation, Fulton County Transit opened its doors for service in August of 1985.

Originally FCTA operated out of a signal office in the back of a local clinic. In March of 1992, FCTA moved its operation to a six room office in downtown Fulton.

Fulton County Transit Authority has been recognized by the Division of Mass Transportation on two separate occasions, once in 1987 for the greatest increase in ridership and in 1991 for the "Outstanding Grantee" in the western part of the state.

The FCTA logo was designed by Andrea Lynch of Fulton, who entered it into a contest in 1985. Lynch was in the sixth grade at the time of the contest.

Service area - Fulton, Graves and Hickman Counties in Kentucky.


Pat Puckett stated that FCTA would like to be able to provide the entire Fulton County area

with transportation at low rates to enhance service.



Like-kind Vehicle Exchange (LKX)

FTA Administrator, Brian Clymer, announced that FTA grantees who remove a federally funded transit vehicle from service before it reaches the end of its minimum useful life are no longer required to remit to the federal government the un-depreciated federal interest in that vehicle in cash. The money may be retained so long as it is re-invested in a like-kind vehicle.

KPTA ANNUAL MEETING SCHEDULED


