Laurel County Intermodel Transit Facility Grand Opening Gate goes up on downtown parking garage

The Laurel County Intermodel Transit Facility, a joint project of the Laurel County Fiscal Court and Rural Transit Enterprises Coordinated, Inc. (RTEC), was officially opened during a dedication and ribbon cutting ceremony held on February 9, 2007.

"We hereby dedicate this great garage," said U.S. Rep. Harold "Hal" Rogers, R-Somerset. "May you park in peace."

With those words and a ship of the scissors by Rogers, the parking garage at the corner of 5th and Broad Streets in London was officially opened.

Rogers took the time to poke a bit of fun at himself as well.

"A lot of members of Congress go home once a month," Rogers said. "I go home every weekend to pick up trash, go to drug treatment facilities and dedicate parking garages."

Local dignitaries including Rogers, state Sen. Tom Jensen, R-London, Laurel County

Judge-Executive Lawrence Kuhl, London Mayor Troy Rudder, former Mayor Ken Smith, members of the Laurel County Fiscal Court and London City Council attended the formal ribbon cutting of the \$4.9 million facility which has been under construction for approximately one year.

Daniel Boone Transit opens new facility in Jackson County

Daniel Boone Development Council, Inc., Executive Director Mike Buckles, along with Congressman Hall Rogers, Mike Patrick, Vickie Bourne and staff of the Kentucky Transportation Cabinet dedicated the New Office/Maintenance facility in Jackson County on Wednesday, November 1, 2006.

Many local leaders and residents were on hand, including members of Jackson County Development Assoc., Kiwanis Club, Judge Tommy Slone, State Representative Marie Rader, and other leaders representing local business and churches. The list of guests included Roger Schott, Chair of Daniel Boone Board, Rockcastle Judge Executive Buzz Carloftis, and other Board members, and, "most importantly Daniel Boone employees who are to be commended for the job they do," said Deputy Director Mona Whitaker.

Federal funding for this project was \$489,916 with a total construction cost over \$625,000.

The new 4000 square foot facility, located on Hwy 290 between McKee and Annville will provide office space and a maintenance garage for Daniel Boone Development Council, Inc.

The maintenance garage will allow DBDC vehicles used in Jackson County to be serviced and maintained here rather than in Clay County.

"I'm really proud of this facility and the staff we have in place in Jackson County," said Director Mike Buckles.

State Representative Marie Rader lauded the efforts of Congressman Hal Rogers and all he has affected for Jackson County. "Congressman Rogers has secured

funding for economic development, the war on drugs, and environmental programs such as PRIDE and without his help, this new facility may never have happened," she said.

Daniel Boone Development Council, Inc., currently has 17 employees at our Jackson Co. office with a payroll over \$500,000.

Taking HART: Bus service says thanks to riders that are 'more or less family'

A free ride usually only takes you so far. But on Thursday, "far" was as far as, and as often as, you wanted to go within the city limits of Henderson.

Normally, bus rides on Henderson Area Rapid Transit would have been 50 cents for regular passengers and 25 cents for the elderly and disabled. But Thursday was the day that HART showed appreciation for its customers, many of whom were just as thankful in return.

"I would be lost without it because I have no relatives and I don't drive," said Donna Lawson, 48, who climbed aboard the northend bus after it made a stop at Wal-Mart on U.S. 41-North.

That route is probably the most popular route out of the five offered that include Weaverton, East Gate, the east end and Henderson Community College, said Pam Whitter, the mass transit coordinator for HART.

She said the program receives funding from city, state and federal coffers, and that many of the passengers in her program are disabled residents.

The wheelchair lift on the four HART buses is used roughly 700 times per month, she said, and there is a Demand Response van that caters to many elderly and special needs residents by taking them anywhere in the city for \$1 per ride.

That's a bit more than what Carolyn Michael pays when she rides the HART bus three or four times per week. But as a disabled person who often loses consciousness and refuses to get a driver's license for safety reasons, having access to HART keeps her going in more ways than are immediately known

Not only does Michael, who is a stranger to the word "stranger," use the bus to go to Methodist Hospital for frequent blood tests, but she also takes the bus to meet new people.

"Sometimes I will get lonesome and I will just need something to do, so I catch the bus just to ride it and talk with someone," the 51year-old said. "It's a way for fellowship and to invite them to my church (Victory Christian Center)."

But others ride the bus for more tangible benefits, like going to the drug store, or buying groceries for the week, or just to run other necessary errands.

Karen Hayden, 45, said she takes the college run bus from the corner of Third and Main streets to get to Gibbs Diecasting, where she works. But that's not the only reason she said the buses are useful.

"A lot of people (on the bus) are people that have been here a long time, and you see people that you used to work with and ... that your parents used to know," she said during a break from a chat with fellow bus rider Leroy Posey, 64.

One not-so-typical bus passenger on Thursday was Glenn Beaver, 76. He and his wife, Lottie, brought their great-grandson, Preston Langston, on the HART bus for the first time. Glenn Beaver has ridden the bus on Passenger Appreciation Day for four years running, even though he and his wife have two vehicles and are not in need of the service.

But they took advantage of the free hotdogs, hamburgers, chips and soda that were available to celebrate the fact that, over the past five years, an average of about 120,500 passengers per year have ridden the HART buses.

The bus service has been provided for years beyond the most recent tabulations.

Passenger Michael said she has been riding the buses for about 29 years, and in that time, HART has expanded its bus routes to allow for more service to the north end of Henderson and to the area around Henderson Community College.

That has allowed her to get to know some of the HART employees quite well.

"They are very kind to people," Michael said. "The bus drivers talk, laugh and cut up with us. It's like we are more or less family."

TARC Video Leads to Capture of Assailant in Louisville

A high-profile crime in downtown Louisville, Kentucky, has been solved with the help of video footage from cameras installed in Transit Authority of River City buses.

The January 30 incident concerned a 14year-old schoolboy who was sexually assaulted after leaving a TARC bus, during his three-block walk to school. Police immediately put out a description of the man, but the suspect was not apprehended until after police released the video from the TARC bus, four days later.

The footage, captured on the bus the boy took near his home before transferring to a second bus, showed a man fitting the description the boy had given, getting on the bus and then disembarking at the same stop as the boy. Within hours, the police received a tip and made an arrest early the next morning.

"It is terrible that the assault occurred, but we are thankful the predator was apprehended, and that we were able to play a role in solving this crime," said TARC Executive Director J. Barry Barker.

After the initial incident was reported, media outlets raised questions about the safety of

students riding TARC buses. But with the release of the video and the solving of the crime, many of those fears were allayed.

"We had the opportunity to demonstrate to the public and our riders that we are always concerned about safety on and off our buses. That's why we are working toward equipping all of our buses with cameras," Barker said.

This incident was the third in the past year that police have used TARC footage as part of an investigation. Last summer, a bus operator noticed when a rider dropped a bag from a fast food restaurant and money fell out. The driver relayed this information to police gathered outside the restaurant. Another incident involved state attorneys using TARC video to prosecute a man charged with assault on a bus.

TARC began installing the cameras on its buses four years ago. The installation, which cost \$8,000 per bus, includes cameras in four interior locations and one exterior. "We're quickly seeing that it's worth the investment," Baker said. Originally, the system noted, the main purpose of the cameras was to improve security for drivers and discourage riders' misbehavior.

A letter sent to Daniel Boone Transit from The Family of Stanley and Beulah Vickers Neeley

We have wanted to write you for some time regarding the courtesy and care with which Daniel Boone Transit has shown our parents and our family during their sicknesses and our Mother's passing.

My Mother was the late Beulah Vickers Neeley. She had to go to Dialysis on Keystone Drive in Richmond, from December, 2005, until she chose to quit in September, 2006. My Mother had to be transported in a wheelchair during her illness. She was very sick from August, 2005, until she passed away on September 28, 2006. During this time, she had shingles; a pacemaker put in, a stroke, a heart attack, other illnesses and a Dialysis access.

My Dad had a stroke and heart attack in late November, 2005. He is paralyzed on the left side and cannot see clearly from the left eye. He also has to be transported in a wheelchair. Both my parents have been

transported by Daniel Boone Transit for doctor's appointments and for other health care.

My Mother had to be transported three times a week for Dialysis. Sometimes she would say she was not going then when Daniel Boone Transit came, she would willingly get ready to go with them. The transit drivers always took great pains to assure she was not in pain or distress from sitting in her chair chair.

The staff at McKee: Linda Truett, Valerie Hurst, Anna Browning, Connie Grimes, and Charlotte Bowling helped us in many, many ways.

My Mother's stroke affected her speech, but her mind was very alert. She loved all the drivers and called them "My Babus". Each of the drivers was very special to her. However, it seemed that many of the days when she refused to go it was Kyle Lakes or Connie Grimes who came to pick her up and she went to Dialysis because of the kind words spoken to her. I can honestly say that I feel their special heartfelt treatment extended her life. She would be terribly upset with us because of having to go to Dialysis and the drivers would show up and after hugs and smiles she was ready to go. Sometimes when she came from Dialysis she was

in a very bad shape, and your drivers were always concerned and attentive of her every need.

When our parents first became ill, we had to make our home handicap accessible and built a ramp as good as we understood. It was very steep and didn't really meet our needs. Shane Rose volunteered an entire Saturday and came to our home to build a ramp for our parents. The new ramp made access in and out of our home so much easier.

Not only were the drivers from Jackson County Daniel Boone Transit good to our Mother, Lee County drivers were also. One day she was falling in the restroom at Dialysis and I could not hold her. I pulled the bell for the nurses, but she was going down so fast I just could not hold her. I yelled for help and Jeff McIntosh from Lee County Daniel Boone Transit came to our rescue. He and another Dialysis family member helped me get my little Mother back in her chair. She thanked and thanked them for helping us. Dennis Isaacs always was very kind to ask if he could help us in any way also.

We had our Family Reunion this year and we were so very fortunate to be able to hire Transit to take our Parents to this most special Reunion. We did not realize time would be so short and this would be our last reunion together, but we could not have done this without you employees.

When my Mother passed away, Daddy was able to go to the Visitation, Funeral, and Graveside Service due to Daniel Boone Transit. There are no words to express the gratitude and admiration we feel for those who represent your agency with such dedication and commitment.

I don't know of anywhere in the United States or the World at large, where anyone would have helped our Parents the way Daniel Boone Transit Staff has. Our parents were extremely independent until their illness. The staff at Daniel Boone Transit preserved our parent's dignity and self-esteem in a time when they and we had to become totally dependant on others for their every need. We feel they are such an asset to our community and especially our handicapped citizens.

We will never forget the wonderful, sincere kindness of your people. Our family is proud to call Linda, Valerie, Connie G., Charlotte, Kyle, Shane, Shirley M, Glen, Connie T, and Shirley I, not only our friends, but our "Rescue Angels". If we can ever be of service to you, please don't hesitate to let us brow.
